The opening balance for the CCUSA was £3,131,70

Scorer's Eyrie

I attended the ACO Conference at Warwick in October and the ECBACO East region's Roadshow at Brentwood in January. The focus of these meetings was the ongoing Officiating Review. Whilst the initial phase is very much focused on umpiring, I am keeping a keen eye on developments and how they might impact on the review of scoring. At the recent meeting of Regional Scoring Officers that I attended, Richard Glynne-Jones, Head of Officiating was asked how the findings of umpire review might impact scorers. His response implied that everything was still very much up in the air and a review of the process would be influenced by the ongoing consultation with scorers and how the review of umpiring progressed. In the meantime we have been told to carry on as normal in regard to scorer education and the provision of courses.

Several courses, including Introduction to scoring, Club Scorer, Level 2 and electronic scoring are available within the ECBACO East region. Details are available on the ACO website. There have been reports that courses are difficult to find on the ACO website as the default setting is for 2019. The ECB have been asked to rectify this. Anyone interested in courses and/or having difficulty finding them should contact me. There is a free Online Basics of Scoring Course available on the ACO website.

As with umpires, scorers are in short supply. Scorers are being pressurised to score electronically and also to get involved with streaming of matches. A competent book scorer is better than no scorer at all so book scoring should not be discouraged. I would argue that all scorers should know how to score on paper before expanding into electronic scoring. Electronic scoring brings its own challenges – availability of electricity, internet connection and position of scorer (scoring outside on a laptop is not easy in bright sunshine and is not ideal in drizzle!). Video streaming is not the responsibility of the scorer and unless the scorer is keen to be involved they should not be asked to do it. There are incidents where scorers have given up scoring rather than have to deal with streaming.

Provision of equipment is also an issue. Who should provide the laptop for scoring? A scorer may not have a laptop or be reluctant to use their own device for scoring. Should clubs provide laptops? If Wi-Fi isn't available who provides internet connection – a scorer can't be expected to use their own data so should clubs provide a dongle? Lots of things to think about. I have made a tentative enquiry to the Board to see if any funds are available for clubs to apply for that could be put towards purchase of scoring equipment.

Umpire Development

An area of real concern was that we were lacking personnel to observe umpires both on and off field. Keith Coburn and myself were the only available people. We hope to have a smoother appointment system in place this year allowing EAPL umpires to stand with a greater number of panel umpires to allow mentoring feedback.

We would like to increase the size of the team of observers so if you're interested in being involved, please make me aware. We are looking to run a refresher session for observers, so prior knowledge or experience isn't essential.

We are looking to develop a mentoring system, where experienced umpires agree to support/mentor newer colleagues as part of their development. This could involve standing together in a match/es and ad-hoc conversations. If you're interested in joining the umpire mentor group please let me know.

Planned is pre-season Whiting Panel meeting to discuss regulations ensuring a smoother introduction into early season matches. Personally I would like to see a marking process from captain's to allow a better feedback environment for both performance and disciplinary matters.

A brief idea of where we hope to be in 2023, so if you are keen to be involved, please make contact.

Umpire Education

We have been approached by the CCA to run some introductory umpiring courses with them. We've agreed the following dates and times.

Sunday 26th 2:00 pm at March Cricket Club

These are largely aimed at players who want to improve their umpiring but all are welcome and they are free of charge.

In addition the intention is to run a stage 2 course in March for anyone who is interested, this will be the last stage 2 course we run before the introduction of the new ECB entry level course in August of 2023. Following that the existing courses will be replaced by the entry level course and then the provision of CPD both locally and by the ECB.

Safeguarding/EDI/Discipline

As the season looms, so does all the activity to ensure that scorers and umpires are all compliant with the requirements of the ECB for administering the game. The obvious one is a DBS that is through the ECB. Other DBS authorisers are not valid, so a teaching DBS is not transferable. To be a member of the ACO you are required to have an ECB DBS. This is at no cost, so long as you click on the volunteers box on the application form.

In addition to having a current DBS, the good news is that your DBS will roll on; so long as you have authorised the annual check via Atlantic Data (The ECB DBS provider). This happens soon after the initial granting of a DBS certificate via email.
