CHAIRMAN'S REPORT 2024

Another relatively trouble-free season was completed for which we thank you, the Clubs. Firstly, a special mention to Foxton Granta for winning the National Village Competition at Lord's in September, an amazing achievement after being beaten finalist eight years ago.

Ramsey were worthy winners of Division 1 but unfortunately, were unsuccessful in EAPL end of season Play-offs. Likewise, congratulations to both Castor & Ailsworth and Waresley for winning Divisions 2 and 3 respectively. However, commiserations must be given to both Upwood and Foxton Granta II who were denied promotion because of Saffron Walden being relegated from the EAPL. This again highlights an issue we all feel, at present the bottom team in the EAPL partake in the end of season Play-offs, when they should be relegated automatically and the 11th team invited to participate in the Play-offs. As usual there are always teams that suffer by being part of the pyramid, however fortunately this year, running Division 3 with nine teams prevented other teams being effected by a relegation they didn't deserve.

After what will be two years, Division 1 is reverting back to ten teams at the end of next season which again will result in some teams being relegated who don't deserve to be. Also, from Division 3 four teams will be relegated to their respective County Leagues. This chopping and changing cannot continue as it has a serious effect throughout our pyramid. However, we could reintroduce the T20 competition in 2026 for those who wish to play additional matches at the start of the season.

We welcome LGR and City of Ely, the latter returning to the League after a 15-year absence, from their respective County Leagues.

At the two End of Season Meetings it was reiterated that the League facilitates what the majority of Clubs wish to play in regards to formats. Now all three divisions are playing matches with both red and pink balls.

As always, the aim of the Committee is to keep the cost of playing in the League to a bare minimum, but with an affiliation payment of just £50 we urge Clubs to make that payment promptly. Unlike other leagues no fines were issued again last season, and when a Club does transgress a quiet word always suffices, thank you.

Finally, I would like to thank Michael Cafferkey for agreeing the sponsorship of the League in full this season, unlike the two previous years where the sponsor reduced their contribution without warning, which is a big factor in keeping the costs to you down. Also, thanks to Paul Jefferson, Tim Steele and Steve Kent-Phillips and the representatives of each Club that form the Management Committee.

THE CAMBRIDGESHIRE & HUNTINGDONSHIRE PREMIER CRICKET LEAGUE CONSTITUTION

League Title

1. The League shall be known as the Cambridgeshire & Huntingdonshire Premier Cricket League and the name of the sponsor may be added as necessary.

Management of League

- 2. The League shall be governed by an annually elected Management Committee consisting of Chairman, Secretary, Treasurer, Welfare Officer, Safeguarding, Registration Secretary and one nominated Representative from each member club. A representative from the Cambridgeshire Cricket Association, Huntingdonshire County Cricket League and Umpires Association shall also sit on the Management Committee.
- 3. The Management Committee shall meet at least three times per annum on a date to be decided by the Secretary.
- 4. The Management Committee shall have the power, by majority, to co-opt additional members at any time without ratification by the Annual General Meeting.
- 5. The quorum for a Management Committee Meeting shall be four.
- Clubs will expected to attend Management Committee Meetings. A fine of £20 shall be levied against a club failing to attend two consecutive Management Committee Meetings and/or the AGM, such fine to be applied at the discretion of the Treasurer.

- The annual subscription shall be fixed annually at the Annual General Meeting and shall be payable by 31st May for the forthcoming season.
- 8. All monies due to the League shall be paid by the required dates. If there are any outstanding on the 30th June, a fine of £50 will be levied on the defaulting club. Any fine not paid within 14 days of invoice will be doubled and if not paid within a further 14 days (28 days from date of invoice) it will be doubled again.

Annual General Meeting

- 9. The League Annual General meeting shall be held between the end of the season and the 1st March each year.
- 10. Proposals and nominations for officers for the Annual General Meeting must be received by the League Secretary by 31st August. Details must be sent to all member clubs with notice of the Annual General Meeting.

Extraordinary General Meeting

11. An Extraordinary General Meeting may be held at any time at the written request to the Secretary, by the Chairman of five Member Clubs. An Extraordinary General Meeting may discuss and amend, or add to, if necessary, any matters appertaining to the League including the constitution and/or playing rules.

Notice of AGM / EGM

12. Notice in writing of 28 days shall be given.

Voting at AGM / EGM

- 13. One vote per member team and league representatives. The League Chairman shall have a casting vote. The quorum at an AGM / EGM shall be at least two-thirds of member teams.
- 14. Except where otherwise stated a simple majority of those attending will decide voting issues.

Eligibility of League Membership

15. The League shall be open to cricket clubs from Cambridgeshire, Huntingdonshire and surrounding counties.

Format of the League

16. The Management Committee shall determine the number of teams permitted, membership of the League and the number of Divisions, subject to ratification at the AGM.

Election of new Member Clubs

17. New teams, once approved by the Management Committee, may be elected by gaining support of a simple majority of those voting at the AGM. All clubs must be affiliated to the ECB via a County Cricket Board and must adopt all ECB policies and Conduct Regulations.

Termination of Membership

 An AGM / EGM shall have the power by gaining the support of two-thirds of those voting at the AGM / EGM to terminate the membership of any club.

The termination proposal must be received in writing by the Secretary signed by the Chairman of five member clubs prior to notice of an AGM / EGM being sent.

19. In the case of failure to meet ECB Safeguarding Policies, after consultation with County Board Safeguarding Officer(s), the League Management Committee may either suspend, relegate, or remove any club from the League, with immediate effect.

Playing rules

20. The Playing Rules shall be printed in the Handbook as agreed at the previous AGM / EGM.

Protests, Disputes and Appeals

 All matters relating to disciplinary issues will be progressed in accordance with the Cambridgeshire & Huntingdonshire Joint Disciplinary Committee's adopted procedure as detailed in Appendix A.

Independent Verifier

22. The League's year-end accounts shall be verified by a person elected at the AGM for the following year.

Sponsorship Monies

 Any sponsorship monies decided at an AGM / EGM will be made available to member clubs and divided into equal parts.

ECB Policies and Conduct Regulations

24. The League will appoint a trained Safeguarding Officer and will be affiliated to the ECB. It will adopt all ECB policies and Conduct Regulations.

Social Media Policy

25. The League requires that it's social media policy is fully observed and that any clips that players or members of a club may take are not used to criticise or vilify any player, umpire or official.

Video streams, photographs and recordings are not to be used to question decisions of umpires or as a Decision Referral System.

Any derogatory comments criticising the League, it's Officials or match officials on Social Media or in the press will result in an automatic 10 point deduction in addition to any other penalties. This also covers any additional comments from members of other clubs.

THE CAMBRIDGESHIRE & HUNTINGDONSHIRE PREMIER CRICKET LEAGUE PLAYING RULES

Fixtures

 All clubs shall play each other twice per season; once at home and once away. All matches will be scheduled to be played on the days issued on Play Cricket, but may be rearranged by mutual consent if before 28 February; however no match will be rearranged thereafter. No club or team may change their home ground without the prior consent of the League Secretary. If permission is granted their opponents must be notified by the Monday prior to the match.

Player Registration

- 2. No player may be registered for more than one club within the East Anglian pyramid structure. However, a player qualified to play in the under 16 or younger age groups may register for a second club but cannot play for more than one team in the same Division. Any player playing in another ECB Premier League without a full transfer taking place (subject to rules 7, 8 and 9 regarding player transfers) will have to serve a seven day qualifying period from the date of the transfer before being eligible to play.
- 3. A Category 1 player must be registered on play-cricket.com before their first league match of the season. In addition, all Category 3 players must complete a Registration Form; once the League Secretary has confirmed receipt of this form the player shall be eligible to play. Any club found guilty of playing an unregistered player shall be deducted any points gained in the match and fined £20 per player.

Clubs may play one Category 3 player or a player on ancestry or visitor's visa only.

4. Additional players may be registered on play-cricket.com during the season. No player may be registered after 31st July of each season unless he has previously been registered as a playing member of the club in a feeder league in the current season.

The feeder leagues are the Cambridgeshire Cricket Association and the Huntingdonshire County Cricket League.

Player Restrictions

- Category 1 No Restrictions. Players in the UK before 1st March of current year on a student or working visa will be deemed Category 1. Those with a UK passport must have completed the 18 month qualification period.
 - Category 3 See Appendix D and must re-register each season

No club can play more than two players whose last two league matches were in any ECB Premier League.

6. All eligibility disputes shall be dealt with by the League Management Committee.

Player Transfers

- A player wishing to transfer between league clubs within the league season shall need the agreement in writing of the Registrations Secretary. Transfers shall not be allowed after 31st July.
- 8. No overseas player shall be permitted to transfer from one member club to another member club in any one season.

 A player may leave any one club and join another during a season provided he has discharged all liabilities to his original club. All transfer disputes between a clubs and players shall be dealt with by the League Management Committee.

Playing Times

10. All league matches shall normally commence at the following times:

Division 1 pink ball	12.00 and 11.30 in September
Division 1 red ball	11.00 always
Divisions 2 and 3	12.00 and 11.30 in September

Match start times may be varied with the agreement of both clubs and the League Chairman or Secretary, who shall inform the Umpire(s) involved in the match.

The Toss

11. The Captains or nominated deputies shall toss for the choice of innings on the field of play not earlier than 30 minutes, nor later than 15 minutes, before the scheduled or rescheduled time for the match to start. In the event of a Captain or nominated deputy not being available to toss during the stipulated time period, the opposing team shall be awarded the toss for choice of innings.

Match Duration

12. Match durations may be reduced with the agreement of both Captains before the toss. Overs allocations will be reduced but although bonus points will remain the same. Match durations may also be reduced by the umpires in the case of inclement weather before the toss. The normal allocations will be as follows:

Division 1 pink ball Division 1 red ball	50 overs a side and (a) 110 overs in the day and (b) and (c)
Division 2	50 overs a side and (a)
Division 3	45 overs a side and (a)

- (a) Any full or part overs unused by the team batting first shall be disregarded.
- (b) Any full overs unused by the team batting first shall be added to the team batting second's allocation
- (c) The side batting first is entitled to 58/110 of the available overs in the day, rounded down. After the start of play, the number of overs per side is not affected by any interruptions.

Teas

- 13. The tea interval shall normally be 30 minutes in duration in all matches and shall normally be taken between innings. The Umpires are empowered to change the timing and length of the tea interval, or to forgo the tea interval altogether, depending upon match circumstances.
- 14. Teas are optional. The home Club must inform the away club that teas are available and at what cost earlier in the week, and the away club must then indicate in good time to the home club whether they want them.

Ground, Weather and Light

15. The Captains may agree to reduce the available overs in a match at any time before play commences; subject to a minimum of twenty overs per side and the limitations as set out in Appendix C.

In all 50 overs matches, Duckworth Lewis Stern (DLS) is mandatory and the home club's responsibility. DLS will not be used in Division 1 red ball matches, nor if the side batting second has not had 20 overs.

In the event that DLS is not available, the League Secretary shall be informed, and the following will be used instead:

- 16. In all cases of time lost, the first 30 minutes of the delay or interruption shall be disregarded. This time is to be cumulative. If less than 30 minutes have been lost in total, no overs are deducted, but the end times of both innings are extended pro-rata accordingly.
- 17. In the event of a delayed start or a delay in the first innings, for every interruption one over shall be deducted from both sides for every full seven minutes of time lost.
- 18. In the event of time being lost in the second innings, one over shall be deducted for every full 3.5 minutes of time lost.
- 19. The par score shall be decided by multiplying the average run rate per valid ball of the team batting in the first innings by the number of valid balls received by the team batting in the second innings, ignoring fractions of a run. If the team batting first is bowled out, their full overs allocation applies.
- 20. A minimum of 20 overs must the played in the second innings to obtain a result in all formats. Should there be insufficient overs remaining after a stoppage to enable 20 overs in the second innings to be played, the match shall be immediately abandoned.
- In Divisions 1 and 2 50 over matches the cut-off time will be 4.05pm and 3.35pm in September. In Division 3 it will be 3.50pm and 3.20pm in September. In Division 1 red ball matches the cut off time will be 3.30pm

Match Balls

- 21. For all matches, two new balls shall be made available as approved by the League Management Committee. Each team shall provide one ball for each innings. The Umpires shall report any club failing to provide an official match ball. A fine of £25 shall be imposed for each offence and reimbursement shall be made to the club providing a new ball where the other team fails to supply one. The colour of the ball used in any particular match is defined in the Fixtures section.
- 22. Match spare balls must be of the League standard and shall be supplied by the home team.

Bowling Restrictions

23. In Division 1 red ball matches, no bowler may bowl more than 14 overs in the first innings and no more than 22% of the available overs in the second. Additionally, in reduced overs Division 1 red ball matches no bowler may bowl more than 22% of the available overs in either innings. In all cases, the 22% is to be rounded up to the nearest full over.

In all other matches, no bowler shall be allowed to bowl more than 20% of the overs available in an innings, rounded up to the nearest full over as described in Appendix C.

In all matches, if the bowling allocation is reduced, any overs already bowled surplus to the amended allowance shall stand. An over in progress at the start of an interruption shall be completed by the same bowler after the interruption. Note: Rules 24-33 do not apply to Division 1 red ball matches.

Free Hits

- 24. For all deliveries that are called as No-Balls, the Umpire shall award a free hit for the next ball to whichever batsman is facing it. If the delivery for the free hit is not a legitimate delivery, then the next delivery shall become a free hit for whichever batsman is facing it, and so on. For any free hit, the striker can be dismissed only under the circumstances that apply for a no ball, even if the delivery for the free hit is called a wide ball.
- 25. No field changes are permitted for a free hit delivery unless there is a change of striker or there are safety issues for close fielders, either in front or behind the wicket.
- 26. The Umpire shall signal a free hit by extending one arm straight upwards and moving it in a circular motion.

Fielding Circle

27. Two semi-circles shall be marked on the field of play with their centres the middle stumps at either end of the pitch and their radii 30 yards. The semi-circles shall be linked by two parallel lines and marked with dots or disks at 5 yard intervals.

Power Plays

28. Power Plays shall consist of three blocks of overs described as Power Plays One, Two and Three in Appendix C; commencing with 10-30-10 overs in Divisions One and Two and 9-27-9 overs in Division Three in an uninterrupted match. 29. In a reduced overs innings, the Power Plays shall be adjusted as described in Appendix C. If an interruption occurs during a Power Play and causes the Power Play overs to be reduced, the Power Play is recommenced immediately upon resumption of play. If an interruption occurs during a Power Play that would cause the Power Play to end, the Power Play is ended immediately upon resumption of play and shall not apply to any remaining balls in that over.

Fielding Restrictions

- 30. At no time shall there be more than five fielders on the leg side, not including the wicket-keeper.
- 31. During the first Power Play (if applicable), no more than two fielders are permitted to be outside the fielding circle, not including the bowler and wicket-keeper. During the second, no more than four are permitted, and in the third no more than five.

Penalties for contravention

- 32. If any fielding restriction is contravened, either Umpire shall immediately call and signal No-Ball.
- 33. If the Umpires fail to notice the contravention, provided the ball has not come in to play for the next ball or time has not been called; and upon being made aware, the Umpires shall confer. If they agree that the contravention has been missed, a retrospective No-Ball shall be called and the current ball shall be treated as a No-Ball.

Coloured Kit

34. All red ball matches will be played in white kit. Division 1 pink ball matches will be played in mandatory coloured kit. Other pink ball matches will have optional coloured kit.

Bouncers And Beamers

- 35. A bouncer is defined as a delivery that pitches and passes, or would have passed, above shoulder height of the striker stood upright at the crease.
- 36. A bowler shall be permitted one delivery as described above per over. The Umpire shall indicate to the bowler and to the striker when such a ball has been delivered. Upon any repetition of such a delivery in the same over, the Umpire shall implement Law 41.6.
- 37. A beamer is defined as a delivery which passes or would have passed on the full above waist height of the striker standing upright at the crease and the Umpire shall call and signal No-Ball for each delivery. If the Umpire deems such a delivery to be dangerous, in the first instance Umpire shall call and signal No-Ball and indicate that this is a final warning. Upon repetition of the offence, the Umpire will implement Law 41.7.

Wide Balls

- 38. Any delivery, which in the opinion of the Umpire, does not give the batsman a reasonable opportunity to score runs shall be called a wide. Apart from Division 1 red ball matches, a line shall be marked 17 inches inside the return creases between the bowling and popping creases and any delivery that passes the striker either on or outside this line on the off side or outside the line of the leg stump of the striker shall be called a wide irrespective of the position of the striker.
- 39. A delivery passing between the legs of the striker and the wicket shall not be called a wide.

Declarations

40. In Division 1 red ball matches, the side batting first (only) may declare their innings closed at any time the ball is dead. In all other matches, neither team shall be allowed to declare their innings closed.

Over Rates

41. In Division 1 red ball matches, the bowling side shall be penalised in the following manner:

Bowling at less than 17 overs/hour 1 league point Bowling at less than 16 overs/hour 2 league points Bowling at less than 15 overs/hour 5 league points

In all other matches, fielding sides are expected to have bowled the first ball of their allocated last over within their allocated time period as indicated by Appendix C. For example, in a normal 50 over innings, this will be 3 hours 15 minutes.

In all matches, no extra time allowances shall be made for wickets taken, drying a wet ball, extras bowled, sightscreen movement or drinks intervals.

Exceptional circumstances (as decided by the Umpires alone) shall be treated as time lost and shall have either over reductions or the innings end time extended as appropriate.

Rules 42, 43, 44 do not apply to Division 1 red ball matches.

42. In shortened matches, the calculated time for the innings shall be 3.5 minutes per over, rounded up to the nearest minute, plus 20 minutes as described in Appendix C.

- 43. The penalty for not having bowled the first ball of the allocated last over in the allocated time is six runs for every over that is short, ignoring part overs. This penalty shall be awarded immediately the allocated time expires, and shall be recorded under "penalty runs".
- 44. If the above penalty is awarded in the second innings and results in the team batting second achieving their target or exceeding a par score, the match is immediately at an end.

Grounds

- 45. A Grounds Sub-Committee shall be appointed by the League Management Committee to determine suitability of clubs entering the League from the feeder competitions. It shall comprise of a minimum of three individuals and shall also deal with pitch reports from Umpires. Failure to meet the Ground Criteria (Appendix E) at the start of a season will result in a 50 point deduction, unless a valid reason for dispensation is granted by the Grounds Sub-Committee.
- 46. All clubs will nominate a home ground before the start of the season. A 50 point deduction will be imposed if the nominated ground is not used for any League match; unless two adverse umpires reports are received for a ground being unfit, when special permission may be granted.
- 47. All clubs must completely cover the pitch during interruptions. Every reasonable effort must me made to ensure the pitch is fully covered 24 hours prior to the commencement of the match unless permission is given by either the League Chairman or Secretary. Upon failure to do so, and a report being received from the Umpires, the guilty party shall be fined £50 and shall be given a 20 points deduction.
- 48. A procedure for pitch reporting shall be agreed between the League Management Committee and Umpires Associations.

49. All creases shall be remarked during the tea interval by the home team. Failure to do so shall result in an Umpires report and a fine of £10 for each occasion.

Sight Screens

- 50. All clubs must have sightscreens at both ends.
- 51. It is the responsibility of the batting side to move sightscreens. By convention, the fielding side shall assist the first time a sightscreen needs to be moved at each end. After that, not having a sightscreen in place shall not be regarded by the Umpire as a valid reason for a batsman not to be ready to receive a delivery. Umpires shall monitor sightscreen movements closely and award penalty runs as appropriate.

Umpires

52. Umpires shall be appointed by the League to officiate at matches and they shall be empowered to exercise their authority to uphold the Laws of Cricket and these match rules.

In matches using pink balls, the umpires may wear white or coloured kit, and they need not match.

- 53. No match shall be cancelled without the agreement of a member of the League Umpires Panel. A fee of £10 is payable to an Umpire requested to assess the condition of the ground.
- 54. The Umpires shall take control of the ground 30 minutes before the scheduled start of play and shall be the sole judges of ground, weather and light conditions thereafter.
- 55. Umpires shall optionally mark clubs on the quality of the ground, playing surface and facilities. These forms shall be submitted to the League Secretary whenever deemed necessary.

56. Each team shall be responsible for paying an Umpire's expenses as determined annually at the AGM. For 110 over Division One matches the expenses are £60 (two Umpires present) / £100 (one Umpire) For all other matches, the expenses will be £50 / £80. If no play is possible the expenses will be £25 / £40. If the Umpire(s) are still present after tea and no play has taken place, the Umpire(s) shall be entitled to full expenses as above.

Payments are to be made on the day and can be in cash or by bank transfer. In the cases of only one Umpire being present, the expenses are to be split 50/50 between the teams.

- 57. For the purposes of these rules, "the Umpire" denotes the Umpire at the bowler's end; "the Umpires" denotes both Umpires acting together.
- 58. All clubs must have separate Umpire changing facilities.
- 59. All Captains, Vice Captains and Umpires must have valid DBS certificates. Scorers are exempt as per ECB.
- 60. Apart from the rules stated here, the Umpires shall apply the Laws of Cricket.

Scorers

61. In Divisions 1 and 2, each team must provide a non playing competent Scorer. If one is not present, the opposing Scorer shall receive £30 on the day from the offending club in cash or by bank transfer. In the case of non-payment on the day, the League will fine the offending club £50 and pass it to the Scorer. In Division 3, the home club (only) must provide a non-playing competent Scorer. In all divisions if a team has no scorer then one of the team MUST score while their side is batting.

Points

62. A team shall win if

it scores the most runs in an uninterrupted match, or

it exceeds the par score in a reduced match, or

the opposition does not achieve at least the par score in a reduced match.

In Division 1 red ball matches the match is a draw if the side batting second does not match the side batting first's total and is not bowled out.

In drawn matches, the team with the higher run rate per over will be deemed to have achieved a 'Winning Draw' and the opponents a 'Losing Draw'. If the run rates are identical rounded up at 0.05 to two decimal places, the team which batted first will be deemed to have the higher run rate.

For the purpose of calculating run rates, if a team declares in the first innings the run rate is calculated based on the number of overs batted. If a team is bowled out in the first innings they will be considered to have batted all the overs that were available to them immediately prior to the fall of the last wicket.

In either event, an over that has been started will be deemed to have been completed.

Winning and losing draws only apply to Division 1 red ball completed matches where the team batting second has had at least 20 overs and is not all out at the close of play.

Win	25 points but no bonus points
Winning Draw	7 points plus bonus points
Losing Draw	2 points plus bonus points
Loss	bonus points only

In Division 1 pink ball matches:

Win25 points but no bonus pointsLossbonus points only

In all Divisions 2 and 3 matches:

 Win
 25 points but no bonus points or 30 points if the opponents are bowled out bonus points only

63. In Division 1 red ball matches the result is a tie if

- (i) The scores are level at the end of the match and
- (ii) The side batting second is all out,

regardless of wickets taken in the first innings.

In limited overs matches the result is a tie if

- (i) The scores are level at the conclusion of an uninterrupted match, or
- (ii) The team batting second achieves exactly the par score in a reduced innings match,

regardless of wickets taken in either innings.

Tied teams shall be awarded 18 points and no bonus points.

- 64. If a match is cancelled or abandoned both sides shall be awarded 7 points. If the first innings is completed, both sides shall be awarded any relevant bonus points from the match.
- 65. If a club cancels a match due to cup travel (see Failure to Fulfil Fixtures) or forfeited, no points will be awarded to them and their opposition will be awarded 25 points.

- 66. If a Club from any of the three Divisions provides a new Umpire on the Umpires Panel they will be awarded 2 points every time that individual umpires that season. In Divisions 2 and 3, if a Club provides a non-playing Umpire for the whole game they will be awarded one point. This will be subject to the number of umpires available on any particular day.
- 67. Bonus points are unaffected by overs reductions. Bonus points shall be awarded as follows

In Division 1 red ball matches:

150 runs scored	1 point	2 wickets taken	1 points
175 runs scored	2 points	4 wickets taken	2 points
200 runs scored	3 points	6 wickets taken	3 points
225 runs scored	4 points	8 wickets taken	4 points

First innings batting points are only awarded up to the end of the 52^{nd} over, but are doubled if a team wins the toss and decides to bat first.

In Division 1 pink ball matches:

League Positions

68. Positions in the league table shall be determined by total number of points. In the event of two or more teams finishing on equal points, the league shall be determined in the following order: most wins, fewest defeats, highest number of bonus points, results in the two matches between the teams, then runs per wicket scored in those matches. If still level, the League Management Committee shall, if necessary, arrange a play-off match.

Failure to Fulfil Fixtures

- 69. If a club has a ECB National Club or National Village Cup game on a Sunday and the travelling is unreasonable, a game may be cancelled on the Saturday to facilitate travel by agreement with the League Secretary.
- 70. Otherwise, In the event of a member club failing to fulfil a fixture for any reason other than inclement weather, they shall be deducted 50 points and fined £100. The team available to play shall be awarded 25 points. No fixtures will be rearranged due to inclement weather.
- 71. All matches are to be played on the date set by the League Secretary. The higher teams in the club must always take priority on all occasions. Seven players must be present and able to take the field for the match to take place. No fixtures will be rearranged after 28 February of each season.

Match Result Reporting

- 72. All home teams must report the scores of a match (runs/overs/wickets) or report the match was cancelled or abandoned on the League Divisional Results WhatsApp Group (07752 241488) by 11pm on the evening of the match. Failure to report by any team will result in a fine of £20 per occasion.
- 73. Prior to the start of the match both Captains shall complete a card detailing the players representing their team and give them to the Umpires. The result and points gained shall be entered after the match, and then the Umpires shall sign the completed result card.
- 74. All score sheets must be entered on play-cricket.com by the home team within 48 hours of the match. Failure to do so shall result in a £20 fine.

ECB Directives

75. All ECB directives and guidelines shall apply and are to be strictly enforced by the Umpires.

Code of Conduct

- 76. A Code of Conduct shall be applied regarding player behaviour and breaches shall be progressed in accordance with the League's adopted ECB GCR and RCR procedures described in Appendix A.
- 77. In addition any on-field barring actions with disciplinary offences deemed to be Levels Three and Four shall not be implemented on the field but referred to an automatic hearing. The full reporting procedures will still be followed as per a Level 2 offence.

Promotion and Relegation

- 78. The winner of Division 1 shall, subject to the rules and criteria as laid down by the East Anglian Premier Cricket League, be eligible to participate in the competition for a place in that League. Should they decline to participate or fail to meet the criteria, then the league runners-up will be similarly eligible.
- 79. The League shall adopt an active promotion and relegation policy. The exact numbers of teams promoted and relegated in each division each season will vary. The general principle will be two up, two down across the divisions and the bottom two teams in Division Three being relegated to their relevant feeder leagues.
- 80. The League shall invite the winners of the top divisions of the two feeder leagues into the competition for the following season provided they wish to participate and meet the league criteria. Should there be more spaces in Division 3 or a winning team declines to participate or fail to meet the criteria, the team coming second in that feeder league will be similarly eligible.
- The League Management Committee are empowered to determine the promotion or relegation strategy in each individual season.
- 82. Any club can choose to be relegated, up to the League AGM. Subsequent requests will be refused. Any such requests for relegation will result in that club being denied the opportunity of promotion the following season; including rejoining the League if applicable.
- 83. If a club chooses to leave the league, they will be subject to a £200 fine and that club will be denied promotion back into the league for three subsequent years.

Other Actions

84. In case of failure to comply with any of the above rules, or in any other exceptional circumstances, the League Management Committee shall have the authority to take such action as necessary in the best interests of the League.

The 2025 season

95. Additional Umpires List (AUL)

Members on this list must not be already on the League Panel and either hold a Umpiring qualification or have attended one of the two Introduction to Umpiring courses held on 1st April at Over Community Centre and on 15th April at Sawston CC. They must also have a current cricketing DBS.

95a. League Panel Umpire

Anyone who wishes to join the full League Umpires Panel is welcome provided they meet the criteria above. The team they align to will be awarded two points for every game they umpire away from their own club up to a maximum of 20 points. Umpires have to be registered on the AUL and they will be entitled to the standard League umpiring expenses.

95b. Club Umpire

In Divisions 2 and 3, a Club Umpire will be accepted onto the AUL providing they meet the criteria above. The team they align to will be awarded one point for every game they umpire (the whole game) up to a maximum of 20 points. They have to be registered on the AUL and they will be entitled to the standard League umpiring expenses. No club has the right to object to any AUL member umpiring, but have the right to report any issues that may arise. T

99. Promotion and Relegation

Division 1 will revert to ten teams in 2026, so the following special regulations are in effect at the end of the season:

- 99a. Division 1: One team will be automatically promoted from Division 2 and three teams will be automatically relegated.
- 99b. Division 2: The winners will be automatically promoted to Division 1. One team will be automatically promoted from Division 3. Three teams will rejoin from Division 1 and three teams will be automatically relegated.
- 99c. Division 3: The winners will be automatically promoted to Division 2. Two teams will be promoted from the feeder leagues. Three teams will rejoin from Division 2 and four teams will be automatically relegated to their feeder leagues. No account will be made of which feeder league the clubs go back to.
- 99d. Play offs: The fourth from bottom team in Division 1 will play off with the runners-up in Division 2 for a place in Division 1; and the fourth from bottom team in Division 2 will play off with the runners-up in Division 3 for a place in Division 2.
- 99e. The play-off matches will not be required if a team is promoted to the EAPCL as the teams finishing second in Divisions 2 and 3 will be automatically promoted; and in this case only three teams will be relegated from Division 3 to their feeder leagues.
- 99f. Other circumstances may arise to cause these regulations to be amended by the League Management Committee. The overall objective will be to have three divisions of ten clubs in 2026.

Players' On-Field Offences

Level 1

(a) wilfully mistreating any part of the cricket ground or any equipment or implements used in the match

(b) showing dissent at an umpire's decision by word or action

(c) using language that, in the circumstances, is obscene, offensive or insulting

(d) making an obscene gesture

(e) appealing excessively

(f) advancing towards an umpire in an aggressive manner when appealing

(g) any other misconduct, the nature of which is, in the opinion of the umpires, equivalent to a Level 1 offence

Level 2

 $\left(h\right)$ showing serious dissent at an umpire's decision by word or action

(i) making inappropriate and deliberate physical contact with another cricketer

(j) throwing the ball at a cricketer, umpire or another person in an inappropriate and dangerous manner

(k) using language or gesture to another cricketer, umpire, team official or spectator that, in the circumstances, is obscene or of a seriously insulting nature

(I) any other misconduct, the nature of which is, in the opinion of the umpires, equivalent to a Level 2 offence

Level 3

(m) intimidating an umpire by language or gesture

 $\left(n\right)$ threatening to assault a cricketer or any other person except an umpire

Level 4

(o) threatening to assault an umpire

(p) making inappropriate and deliberate and/or dangerous physical contact with an umpire

(q) physically assaulting a cricketer or any other person

(r) committing any other act of violence

Also

A cricketer shall also be in breach of these RCR on and around the field of play if they:

(a) commit any breach of Law 41 of the Laws of Cricket (Unfair Play)

(b) act in a manner contrary to the ECB's Anti-Discrimination Code

(c) conduct themselves in a manner or act in a manner which is improper, or which may be prejudicial to the interests of cricket, or which may bring the ECB, the game of cricket or any cricketer or group of cricketers into disrepute

Others Present

5. Any coach, match official or club official shall be in breach of these RCR if they fail to conduct themselves fairly and properly at any part of the cricket ground on any match day. Conduct which is not fair and proper and will therefore result in a breach of these RCR shall be reported either to the Umpire, in which case the Umpire will make a disciplinary report, or to the Disciplinary Officer directly by way of written complaint (for example, if the on-field breach relates to a match official). If there is no umpire appointed to a particular match, individuals can report on-field breaches to a Captain or Club Official who can then make a disciplinary report on their behalf. The following apply:

(a) making inappropriate and deliberate and/or dangerous physical contact with, threatening to assault, physically assaulting or committing any act of violence towards any other Participant (including an umpire) or any member of the public

(b) showing dissent at an umpire's decision by language or gesture, advancing towards an umpire in an aggressive manner when appealing or intimidating an umpire by language or gesture

(c) using language that, in the circumstances, is obscene, offensive, insulting or seriously insulting

(d) making an obscene or seriously insulting gesture

(e) conducting themselves in a manner or acting in a manner which is improper, or which may be prejudicial to the interests of cricket, or which may bring the ECB, the game of cricket or any cricketer or group of cricketers into disrepute

(f) acting in a manner contrary to the ECB's Anti-Discrimination Code.

Captains and Clubs

If any cricketer commits two or more Levels 3 or 4 offences when playing for the same club in a season it shall automatically be a separate offence of failing to ensure that the relevant cricketers have complied with their obligations for each of:

(a) Any person who captained the team in each of the relevant match(es)

(b) The club the cricketer was playing for.

Clubs shall also be held responsible for disorderly behaviour at any part of the cricket ground on any match day by their members and spectators, unless they can show that:

(a) they took adequate steps to ensure that their members and spectators behaved in an orderly fashion

(b) they did not or could not control entry to that part of the cricket ground by the relevant spectators and it would therefore not be fair for them to be held responsible.

Off-field Conduct

Any participant shall be in breach of these RCR if they commit any misconduct as set out below which either relates to their participation in recreational cricket and/or is of a sufficiently serious nature to justify disciplinary action being taken in relation to their participation in recreational cricket:

(a) making an abusive, obscene, offensive or otherwise insulting comment or gesture (in any form) in relation to any other Participant or any other person

(b) any act of violence towards another person

(c) engaging in behaviour that constitutes any form of abuse or harassment, whether physical, sexual, emotional, neglectful or bullying in nature

(d) any breach of the ECB's Anti-Discrimination Code

(e) making any adverse public statement or comment in any form and by any means about the performance and/or decision(s) of any match official(s)

(f) failing to report to their club any relevant criminal offence for which they have been subject to investigation and/or charged with

(g) conducting themselves in a manner, or doing or omitting to do anything which is or may be prejudicial to the best interests of cricket, or which may bring or does bring the game of cricket or the ECB into disrepute

(h) engaging in any corrupt conduct in relation to cricket

A club shall be in breach of these regulations if, at any time, it:

(a) fails to take reasonable steps to ensure the good behaviour and conduct of their participants for any breach of these regulations

(b) knowingly permits a cricketer, who is suspended as a result of a previous breach of these regulations, to play in any match or competition

(c) any of its Participants commit any serious, collective or repeated breaches of these regulations

(d) commits any breach of its obligations under the ECB Anti-Discrimination Code;

(e) fails to comply with any decision(s) and/or sanction(s) validly imposed on it or on any person within the organisation, which has arisen following due process as prescribed by these regulations.

In addition

Repeat offences are within 24 calendar months

Fines will not be issued, only cautions and match bans

Any offence ban will be increased by one match if it is for a Captain for failing to control his players

Levels One and Two will carry automatic bans

Any bans will only apply to the competition the offence(s) occurred in and not to any other matches

Any reports about Umpires regarding any of their decisions will be disregarded

Where applicable, bans will be carried over to apply in the following season

Level One offences will not usually result in a hearing

APPENDIX D

QUALIFICATION OF CRICKETERS NOT ORDINARILY RESIDENT

- 1. A Category 3 player is one not deemed 'Ordinarily Resident'.
- 2. No team shall field more than ONE Category 3 player. The most common visa types within cricket are the International Sportsperson Visa, Standard Visitor Visa, Tier 5 Youth Mobility and Ancestry Visa. In addition a category of Non-Visa National, which isn't an actual visa, is allowed. All these visa types determine the player as a Category 3.
- An amateur player on a Working Visa or Tier 4 [Student] Visa will be considered Category 1 subject to meeting the criteria in paragraph 7 below.
- 4. Clubs must ensure all the relevant regulations are complied with and, if they are not, any such played will be deemed ineligible for registration. Registration is via play-cricket.
- 5. Clubs registering a player on a International Sportsperson Visa must, when registering the player on play-cricket, email the League Secretary a copy of the player's passport and visa that allows him/her to play cricket/work in the United Kingdom.
- 6. For all other players not deemed 'Ordinarily Resident', Clubs must forward a copy signed by the player of the following declaration when registering a player on play-cricket.

"I confirm that I have been resident in England and Wales for the past 18 months and, during that period, I have not been outside England and Wales for longer than 35 days consecutively or 70 days in total during the previous 24 months. I also confirm that any payment I receive for playing cricket is not my main source of income. I understand that the punishment for making a false declaration in this regard will be severe and will, most likely, result in a lengthy ban which will apply to forms of recreational cricket in England and Wales." The declaration must be submitted to the League Secretary by email with a copy of the player's passport or a copy of the visa that allows him/her to remain in the United Kingdom.

- An unqualified or overseas amateur player who is transferred to the UK for education or work purposes prior to 1st April in the year of his request for registration will be given Category 1 status.
- 8. In the event of a player making a false declaration, the club will also be liable to disciplinary action if it has failed to carry out all reasonable checks on the player's documentary evidence. Clubs will therefore be expected to keep a record of such checks.
- 9. If a player who has been granted qualified status due to personal reasons has to leave England and Wales for longer than the permitted period, or a player who has a home in England and Wales, the Channel Islands or the Isle of Man and has been granted 'exempt' status and subsequently accepts a temporary work assignment, unconnected to cricket in another country, then the Club may apply to reinstate his/her 'exempt' status immediately on his/her return. Approval is at the League's discretion and is not automatic.
- 10. The Home Office "Visa Overview and Overseas Players Professional v Amateur Definitions" provide clarity over what Visas players can/should enter the UK on.
- 11. The International Sportsperson Visa (Non-First Class Player/Coach) is the usual way that an overseas player meeting the home office definition of a 'professional sportsperson' gets a visa to play as a professional in the non-first class game. They have to meet both the playing and coaching criteria detailed on pages 13-16 of the ECB Governing Body Endorsement 2024 document. The club must have a Sponsor Licence Governing Body endorsement. The Visa requires the Recreational Game Migrant Governing Body Endorsement (GBE) application: COACH-PLAYER.

APPENDIX E

GROUND STANDARDS - 2025

A nominated ground or grounds confirmed by 30th October 2024. Those Clubs using two nominated grounds must identify which ground is being used for each fixture by 28th February of that particular season, and these must be strictly adhered to.

A well-maintained Pavilion with at least two players dressing rooms totally enclosed from the rest of the Pavilion with access to working showers.

A separate room for the umpires, containing chairs and a table, with coat hooks attached to the wall; preferably with working showers, a mirror and a bin.

A clean hygienic kitchen area with running water.

Disabled access to the pavilion (wherever possible) with two separate toilet facilities for males and females, and preferably one for disabled users.

A well-maintained square and outfield with a boundary marked by either a line with boundary flags, boards or a rope and at least one sightscreen at each end.

A scorebox (or an inside facility with a view of the pitch) to be in place by the start of the 2026 season.

Covering of the pitch by either roll-ons or plastic sheets which cover the run-ups to the length of at least four yards at each end.

Failure to have any of these in place prior to the first home game of the season will result in a $\pounds 200$ fine, and a 50 point deduction.

Dispensation will be considered during the season if things change which are beyond a Club's control.
